

The FontPanda.com eBook Font End User License Agreement
Version 1.1 - May, 8 2014

By downloading, installing and/or embedding the licensed font software from FontPanda.com ("Font") in any eBook software ("eBook"), the purchaser or designated licensee ("Licensee") agrees to be bound by the terms and conditions of this end user license agreement ("EULA"). This EULA, in conjunction with the receipt ("Receipt") that accompanies each purchase from FontPanda.com or its distributors, constitutes the complete agreement ("Agreement") between the Licensee and FontPanda.com.

This Agreement allows for using the Font within eBooks with the following rights, requirements and restrictions:

1. Rights

- a. Licensee may embed the Font into eBooks.
- b. Licensee may embed the Font into an unlimited number of copies of the eBook.
- c. Licensee may embed the Font into unlimited, subsequent versions of the eBook.
- d. Licensee may embed the Font into unlimited eBook format types.
- e. Licensee may modify or convert the Font to improve the Font's appearance or performance in the eBook.

2. Requirements/Restrictions

- a. When the Font file is distributed as part of an eBook, the font must be embedded within an archive file that obscures the original data using compression, encryption, or obfuscation. Valid archive formats that meet this criteria include, but are not limited to, PDF, EPUB 2.01, EPUB 3, and KF8.
- b. eBook must take the form of a non-executable file which is interpreted by e-reading software or e-reading devices.
- c. Font may not be installed in the operating system the eBook runs on.
- d. Font may be embedded in no more than the number of eBooks indicated in the Receipt.

3. Third parties and Transferability

Licensee may temporarily provide the Font to a producer, publisher or other agent who is working on behalf of the Licensee, only if they agree to use the Font exclusively for Licensee's work, agree to the terms of this Agreement, and retain no copies of the Font upon completion of the work.

Licensee may not otherwise distribute the Font to third parties or make the Font publicly accessible except by embedding or linking in accordance with this EULA.

4. Terms

Rights granted by this Agreement are perpetual. FontPanda.com will not charge additional fees post purchase, annually or otherwise.

5. Other Usage

Licenses for Desktop use, @font-face embedding, computer applications and games, installable interactive books, software, mobile applications and games, product creation websites, website template distribution, website templates, and other uses not allowed by this Agreement may be available for an additional fee. 6. Modifications

Licensee may not modify the Font or create derivative works based on the Font without prior written consent from FontPanda.com or the owning foundry except to generate files necessary for embedding or linking in accordance with this EULA.

7. Copyright

Licensee agrees that the Font is the exclusive property of the owning foundry and is protected by copyright and intellectual property laws. Licensee may be held legally responsible for any infringements on the foundry's rights caused by failure to abide by the terms of this Agreement.

8. Termination

Licensee agrees that the Agreement shall automatically terminate, without notice from FontPanda.com or the owning foundry, if Licensee fails to comply with any provision contained herein.

9. Disclaimer and Limited Warranty

FontPanda.com warrants the Product to be free from defects in materials and workmanship under normal use for a period of twenty one (21) days from the date of delivery as shown on Receipt. FontPanda.com's entire liability and Licensee's exclusive remedy as to a defective product shall be, at FontPanda.com's option, either return of purchase price or replacement of any such product that is returned to FontPanda.com with a copy of the invoice. FontPanda.com shall have no responsibility to replace the product or refund the purchase price if failure results from accident, abuse or misapplication, or if any product is lost or damaged due to theft, fire, or negligence. Any replacement product will be warranted for twenty one (21) days. This warranty gives Licensee specific legal rights. Licensee may have other rights, which vary from state to state.
